The Board of County Commissioners meeting in session Monday April 20, 2020. In compliance with the CDC guidelines to maintain social distancing and stay at home order Commissioners conducted the meeting over ZOOM. Members attending were Rodney L. Allen, Joel S. Fager and Jim Suber. Chairman Fager called the meeting to order at 9:00 a.m. and opened with the Pledge of Allegiance.

County Attorney Tim Liesmann and County Clerk Jennifer Savage were in attendance.

COVID-19

County Health Administrator Ray Finley said there is one positive case in Wabaunsee County at this time, an employee at Alma Foods. Finley said Alma Foods was very proactive and shut down their operations until May 3rd and are doing extensive decontamination procedures. It was noted the Governor has extended the stay at home order until May 3rd.

Commissioner Fager asked if we are still closed to the public, is it acceptable for some departments to come back to work. Finley said he would have to look at each office/department and see if disinfectants are in place, if employees wear masks the risk is cut significantly.

Commissioner Suber asked how we are going to promote the sales tax renewal issue that will be on the ballot his fall. County Attorney Liesmann said we can educate the citizens, but we cannot promote. Commissioners discussed ways to begin educating the public.

Appraiser 2021 Budget request

County Appraiser Ryan Michaelis presented the 2021 budget request for his department of \$140,075. The 2020 approved budget was \$149,970. Michaelis said the decrease is due because of him splitting his time with Morris County.

Michaelis provided a COVID-19 Policy public announcement that will be placed in the papers. Michaelis said they will do reinspection's and sales inspections as required by K.S.A. 79-1476, but they WILL NOT MEASURE OR INTERVIEW. If they visually notice a change in the property wit will be noted to go back later in the year to reinspect and measure improvements.

Other Business

The minutes of March 30, April 6 were approved as presented. Commissioner Fager requested a correction to the April 13th minutes to state the school resource officer grant the Sheriff Department has applied for the schools will cover 25% for 3 years. The only difference will be employee insurance and the Sheriff Department will be giving a car to the school.
