The Board of County Commissioners meeting in session Monday, June 28, 2021. In compliance with the CDC guidelines to maintain social distancing Commissioners conduct and record the meeting over ZOOM. ## **Planning & Zoning**

9:00 AM Commissioner Fager opened the Floodplain Hearing for public comment on Resolution 2021-21 Floodplain Management replacing Resolution 2007-05. There was no public comment presented.
