Regular Meeting Minutes September 12, 2022

The Board of County Commissioners meeting in session Monday, September 12, 2022.

Commissioners conduct the meeting in person and over ZOOM. Member attending in person was Nancy L. Hier, members attending by zoom were Rodney L. Allen and Joel S. Fager. Commissioner Hier called the meeting to order at 9:30 AM and opened with the Pledge of Allegiance. Road & Bridge Supervisor Thayne Bush, Zoning Administrator Noel Sylvester, Sheriff Rob Hoskins, County Attorney Tim Liesmann and County Clerk Abby Amick were in attendance in person others joined via zoom.

**Budget Hearing**

At 9:32 AM Commissioner Hier opened the County Budget Hearing. Commissioner Hier moved to adopt Resolution 2022-25 a Resolution to exceed the Revenue Neutral Rate for Wabaunsee County; Commissioner Fager seconded. Commissioner Hier called for a Roll Call Vote; Fager – Yes, Allen – Yes, Hier – Yes. Motion carried 3-0.

Commissioner Hier asked for public comment on the 2023 Wabaunsee County budget, there was none. Commissioner Hier moved to approve the 2023 Wabaunsee County budget of 55.778 mills as published; Commissioner Allen seconded. Motion carried 3-0.

Commissioner Hier moved to adopt Resolution 2022-26 a Resolution to exceed the Revenue Neutral Rate for Wabaunsee County Fire Districts 3, 4, 5, 6, 7 and 8; Commissioner Fager seconded. Commissioner Hier called for a Roll Call Vote; Fager – Yes, Allen – Yes, Hier – Yes. Motion carried 3-0.

Commissioner Hier asked for public comment on the 2023 Budgets for Wabaunsee County Fire Districts 3, 4, 5, 6, 7 and 8, there was none. Commissioner Hier moved to approve the 2023 Wabaunsee County Fire Districts 3, 4, 5, 6, 7 and 8 budgets as published; Commissioner Allen seconded. Motion carried 3-0.

**Other Business**

Commissioners reviewed and approved wage change forms and expenses for Aug 25 – Sept 7, 2022. Vice-Chair Hier reviewed and approved Daily Statements for August 22, 23, 24, 25, 26, 29, 30, 31, September 1, 2, 6 and 7, 2022. Vice-Chair Hier reviewed and signed Tax Abatement #2021-AB23 for \$18.00 and Added Taxes #2021-04 for \$1,089.88; #2021-05 for \$1,111.52; and #2020-23 for \$434.36.

Commissioner Fager moved to approve the minutes of the August 29<sup>th</sup> Commission Meeting; Commissioner Allen seconded. Motion carried 3-0.

Commissioners selected Nancy Hier to be the Voting Delegate for Wabaunsee County at the Kansas Association of Counties 2022 Annual Meeting.
