

RESOLUTION NO. 2021- 18

**A RESOLUTION CANCELLING CERTAIN CHECKS OR WARRANTS OF  
WABAUNSEE COUNTY, PURSUANT TO THE PROVISIONS OF K.S.A. 10-815.**

WHERE AS, certain checks or warrant s, as described in this Resolution, have been issued on the Accounts of the county treasury of Wabaunsee County, Kansas and a period of two years have elapsed since the signing of such checks or warrants, and during such time no person entitled thereto has appeared to claim such check or warrant, or such check or warrant has not been presented to the county treasurer for payment, and,

WHEREAS, K.S.A. 10-815 authorizes the Board of County Commissioners to cancel and set aside on the records of the County the checks or warrants described herein, which checks or warrants have not been claimed or presented to the county treasurer for payment for a period of two years since the signing of such checks or warrants.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY  
COMMISSIONERS OF WABAUNSEE COUNTY, KANSAS:**

Section 1. The checks or warrants of Wabaunsee County, Kansas, attached hereto and incorporated herein are cancelled and set aside on the records of the County, and the records of the County shall recite and reflect that such checks or warrants are unpaid but cancelled by reason of this Resolution and the provisions of K.S.A. 10-815.
